R21 Reimbursement Request

A motion was made by Jim Morkert, seconded by Chet Makinster, to approve the request for hearing aid reimbursement. The motion passed unanimously.

R15 Reimbursement Request

A motion was made by Chet Makinster, seconded by Jim Morkert, to approve R15's reimbursement request upon confirmation that the services to be provided are not eligible for reimbursement through Medicare or Humana. The motion passed unanimously. Board Secretary Cody will report back the results of the investigation at the regular meeting in February.

New Claim Form Review

Board Secretary Cody presented a simplified LEOFF-1 Claim Form for consideration. A motion was made by Chet Makinster, seconded by Jim Morkert, to approve the new claim form. The Board directed Board Secretary Cody to provide the LEOFF-1 retirees with the revised form and to also solicit email addresses for more efficient communications with the retirees.

Payment of bills

It was moved by Jim Morkert, seconded by Christine Schott, to approve the bills as presented, reasonable and medically necessary. The bills presented represent Medicare payments for December 2020, January 2021 and February 2021, as well as individual medical reimbursements for December and January. Upon a vote duly held, the motion passed unanimously.

New Business

Board Secretary Cody advised that she attempted to contact Member-at-large Bob Steele due to his frequent absences from meetings in the second half of 2020. Jim Morkert reported to the Board that Bob Steele recently passed away. Board Secretary Cody was directed to compile a list of interested volunteers for the Board's review at the regular meeting in February.
