- **APPROVAL OF MEETING NOTES**

A motion was made by George Winn, seconded by Elizabeth Stratton, that the notes be accepted and approved. Passed unanimously.

- **OLD BUSINESS**

- LONGVIEW BICYCLE PLAN

Still under review. Some comments have been turned in and will be incorporated. A small group may meet to review.

- ACTIVE TRANSPORTATION - BIKE RACKS

Street Crews have volunteered to install the bike racks. Morgan will be working with them on proper placement. The bike rack from the Library has been moved from the library to City shop. A business owner downtown has offered to donate a used bike rack.

- CITYWIDE SPEED STUDY – SIGN INSTALLATION

Crews have installed all of the new 25 mph signs. Public reaction has been 50/50. LPD is granting a lot of grace. The feedback sign on 7th Ave is temporary.

- FESTIVAL BIKE PARKING/RIDING GUIDELINES

More to come on this in the future.

- CASCADE'S BIKE, WALK, ROLL SUMMIT

Morgan was able to attend a couple sessions. Hopefully, if the summit is offered next year in the same format, more can also attend.

- TAP GRANT APPLICATION

Four applications were submitted, approximate cost estimate:

- \$5,000 Festival bike racks
- \$55,000 Advisory bike lanes
- \$150,000 Rail trail ROW Acquisition
- \$270,000 Buffered bike lanes

Decisions could come in December.

Ken Hash has been self-promoting the City on four different Complete Streets Grants. There's not an application process but a nomination process.

Dave Fine would like to move forward with a Bike Friendly City (BFC) application. Again, the group is working to finish the Master Plan first then a short follow up with the BFC. Right now the League of American Bicyclist has sponsors covering the cost, so that would be another reason to move quickly.

George Winn inquired about the leaf litter pick up program. It's dangerous for people using the street that aren't on four tires. It seems like it isn't in alignment with other cities.

Dave Fine informed the group of a training program that Cascade offers a 1 hr training program. It's \$75 for a 1 on 1 training. Dave has reached out to Cascade about a train the trainer program. Maybe it could work into a Recreation program. He's seeking anyone that might be interested in starting this program.

Clark Carroll asked about the status of the Washington Way project. It is planned to begin in 2023.

Beech Street extension, with a reduced speed limit, is scheduled to open next Thursday.
