*Morgan Palmer provided an update. Three of the four corners are not ADA compliant. There are a significant number of tire marks on the curb and sidewalk, posing a potential safety concern that can be remedied when the curbs are updated. Public Works plans to collect traffic data on Mt Solo to determine usage as there have been complaints from residents regarding trucks using the route.
The requestor has not returned attempts at outreach.*
