UNFINISHED BUSINESS

26-00386 JANUARY 20TH COMMUNITY MEETING - REPORT BACK FROM MAY 14TH COUNCIL MEETING

Nick Little provided an update from the report given to City Council on May 14th. Council's direction was to move forward with an RFP for the Schneider lot, explore improving lighting downtown by potential grant funding and revamping the Revolving Loan program. There was excitement that lighting and the revolving loan program will be moving to the forefront for DAC to expand on moving forward.

26-00387 DOWNTOWN SIGNAGE - REPORTING BACK

Nick Little was not able to research fully the information on signage spacing requirements. He'll work on that for next meeting as that is the next step needed.

26-00419 UPDATE ON DOWNTOWN PARKING STATUS (SPOTS)

Nick Little has been working with Chief Huhta on revising the LMC for parking requirements. We will start with the changes only in the Downtown area as there is many needed changes for all parking requirements city wide. His goal is to bring this to Council on June 11th.

Nick was thanked for all the hard work to tackle all of these issues that we've been discussing for years.
