2. **CALL TO ORDER**

4. **APPROVAL OF MINUTES**

26-00518 **MINUTES FROM MARCH 24, 2026
NO MEETINGS WERE HELD ON APRIL 28TH AND MAY 26TH.**
The minutes were approved as presented. This passed unanimously.

5. **PROJECT UPDATES**

26-00519 **SYSTEMIC PEDESTRIAN CROSSING IMPROVEMENTS**

Morgan Palmer shared the changes at Hemlock. The elimination of the southern crosswalk was discussed. A central crosswalk was suggested and removing the northern crosswalk. Jennifer Leach spoke on this item as a liaison for the Longview School board. Removing the stop signs on 28th was suggested if Hemlock is closed. This proposal will be set up to observe the traffic patterns. It would also assist with Go 4th festival attendees.

Morgan Palmer shared the changes at Louisiana. It was suggested to keep the Magnolia St open onto Louisiana as one way out.

Morgan Palmer shared the preliminary plans for 7th Ave at Broadway. Bike lanes are not included in this revision.

Morgan Palmer shared the preliminary plans for 7th Ave at Florida. There are existing bike lanes at this location. It was suggested to explore the option for more ADA parking in the parking lot.

Future meeting topic - greenery is obscuring stop signs. Nancy suggested using the AskLongview app to report these locations. Morgan stated that emails could be sent to him to report these.

It was discussed that the stretch of road on Nichols in front of RA Long become a school zone by the school resource officer.

Open House on these topics will be tomorrow, Wednesday, June 24th. Morgan is also presenting on Thursday, June 25th at City Council.

6. **OTHER BUSINESS**

26-00520 **E-BIKES DISCUSSION**

This topic has been brought to us to discuss regulations by Ruth Kendall and Chris Collins. Education is so very important! The public doesn't know what the current regulations are on electric bikes. Youth (under 16) aren't educated in the rules of the road, so when they are on an e-bike, they aren't always following the rules of the road. Drivers aren't looking for 20 mph e-bikes that are coming off a sidewalk. The grant for bike education is on a 2 year cycle for Wa State Active transportation, and it has already passed. It was suggested to see if there's any local donors that would like to put on an education course.

Ivy Masters made a motion asking staff to research to finding costs and funding for signage for sidewalks advising no bikes on sidewalks.

Morgan Palmer suggested a different perspective. The code doesn't call out that bikes aren't allowed on sidewalks. The signs could be educational rather than punitive. It was suggested to work with the COG on transpiration education. Could there be a program established in the schools on e-bikes? Ivy Masters is volunteering to be an education advocate or instructor.

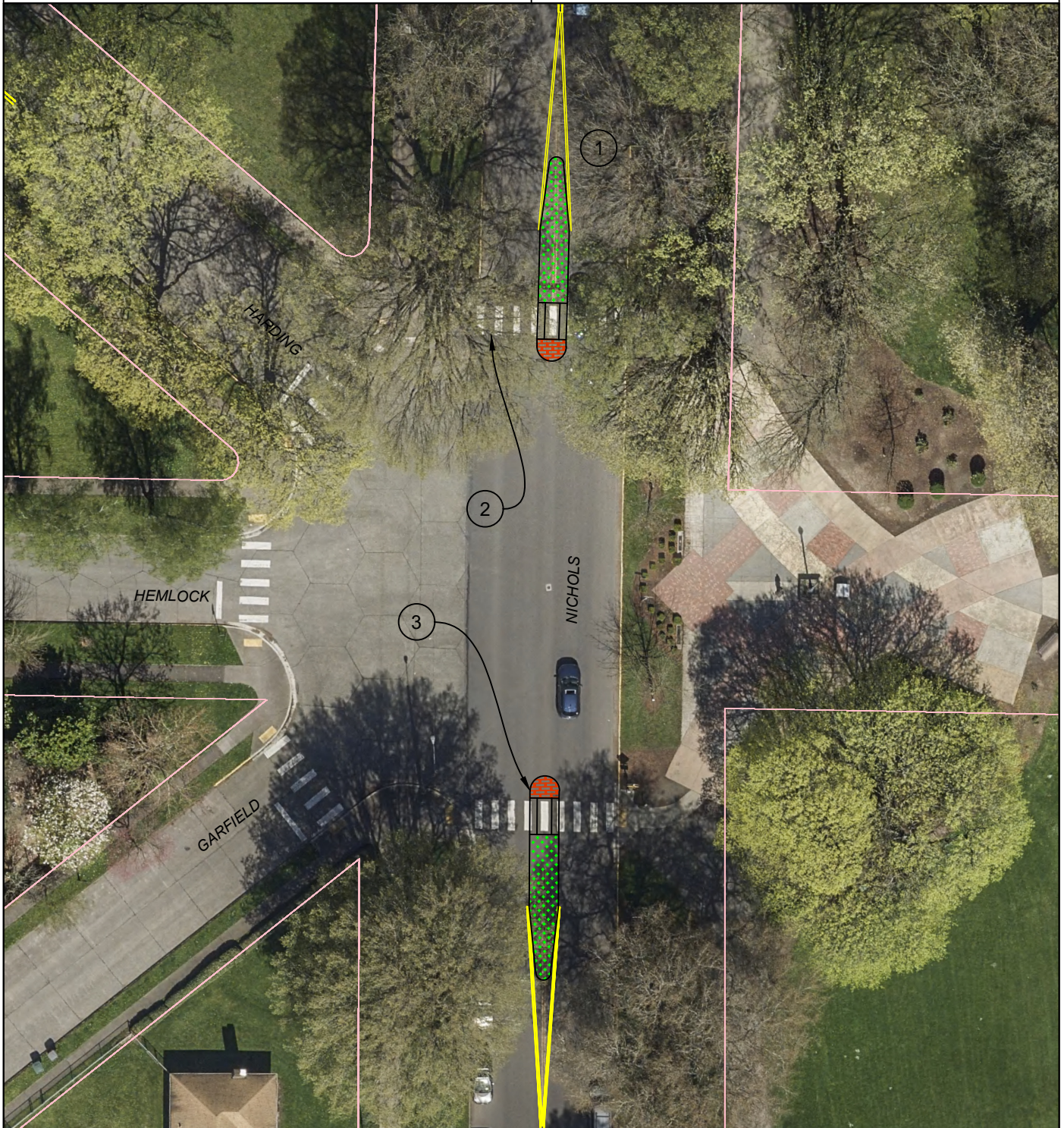
This is a big topic that will be explored at our next meeting. Morgan will research other cities and bring that back to the group. Helmet laws should be implemented.
